Who Can Attend: Any active member may attend any meeting.

Who Can Run: A member must be in continuous good standing for a period of twenty-four months prior to the month of

January 2026.

Who Can Nominate: Members in good standing (full dues paid through December 2025) may nominate or second the

nomination of a candidate or slate of candidates.

Nominations: Nominations may be made or seconded orally at the nomination meeting or submitted in writing to the

Secretary-Treasurer not later than 5:00 p.m.of the day immediately prior to the relevant meeting. It shall be signed by the member submitting the nomination or second and shall provide his/her complete mailing address. The submitting individual may also choose to provide the last four digits of his/her

SSN/SIN.

Candidate A member may accept nomination in person, or if absent from the meeting, by furnishing a written

Acceptance: acceptance to the presiding officer not later than the time the member is nominated. It shall be signed by

the member submitting the acceptance and shall provide his/her complete mailing address. The

submitting individual may also choose to provide the last four digits of his/her SSN/SIN.
